








Floor plans

A first impression

We offer for sale a commercial complex located directly on the seafront promenade of Trani. The business includes licenses for a bar, restaurant, and fish market.

The activity is situated on a seafront area with a state concession granted by the Apulia region, valid until 2031, with automatic renewal of the concession.

The complex is clearly visible from the promenade and consists of several buildings. On the first floor, there is a bar with a large outdoor area overlooking the promenade, offering table service for coffee, ice cream, and other refreshments.

On the ground floor, also facing the sea, there are additional premises, including one with a restaurant license (see attached floor plans and photos), featuring a covered area for outdoor table service. The kitchen is mainly focused on fish dishes and local specialties, supported by a pizza oven, offering regional cuisine designed to satisfy all tastes.

The complex has a large parking area with access from the seafront road.

On the left side of the complex, there is a shop for the sale of shellfish and other products. The fish market has tanks supplied with seawater, used for marketing, purification, and live maintenance of edible shellfish, bivalves, tunicates, gastropods, echinoderms, and lobsters. This allows the sale of fresh and live products.

Finally, the complex is equipped with a photovoltaic system that supports the electricity consumption of the business and generates additional income from solar energy production.

- Parking for customers in the concession area
- Seawater extraction plant, which is fed into various tanks for:
- edible mollusks
- lamellibranchs
- tunicates
- gastropods
- echinoderms
- Several cold rooms
- Photovoltaic system on the roofs of the housing units for energy needs
- Ornamental swimming pool and a small beach equipped with sunbeds and deck chairs Activity codes:
- Code 47.23: Retail trade of fish, shellfish and molluscs
- Cod. 53.3: Bars and other similar establishments without a kitchen
- Cod. 56.10.3: Ice cream and pastry shop
- Cod. 56.10.11: Catering with food service (bar, restaurant)

Other information

Currently, the entire property is located on state-owned land with permits valid until 2031, with a renewal request for an additional period.

For the purchase of the property, the owner may consider negotiating a rent-to-buy agreement or a down payment of 35% of the agreed price; monthly installments are to be defined, with the deed transfer occurring upon renewal of the concession.
